Shipping Agreement:

- 1) Standard Shipping Policy is that Buyer must prepay for shipping and handling. No shipping on Buyer's Fedex / UPS / DHL / Airborne / Carrier account, for both international and domestic shipments.
- 2) Foreign customers are responsible for all applicable customs, duties, VATT, and all other local or import taxes.
- 3) Buyer is responsible and agrees to pay all applicable Duties, Taxes, and Customs **upon receipt of merchandise**. Any delays in payment of these charges or non-payment of these charges to carrier will result in termination of Reseller Status and authorization of credit card on file to be charged at any given time period with reference to shipment received by Buyer. Receiving goods from Dollar Computer requires that understand you must pay these charges.
- 4) If shipping carrier is unable to collect freight charges from Buyer, credit card on file is authorized to be charged.
- 5) Due to our high volume of shipments, Dollar Computer receives privileged shipping rates and passes on those discounts to you.
- 6) Dollar shipping prices include discounted carrier rates, Truck Deliveries, Air/Ground Shipments + additional charges + packaging + labor.
- 7) Refused or Unauthorized Returned products will be charged a 20% restocking fee. Your Privileged Reseller Status will be Voided.
- 8) Do not accept boxes that have been torn or damaged in transit. Test all products ASAP to verify products have not been damaged in transit. If boxes are received damaged – contact Dollar Computer ASAP and **do not** throw the boxes away! Buyer MUST request an RMA number for any defective products no later than 30 days from the date of the posted invoice. NO Exceptions!
